COURSE SYLLABUS

COURSE DESCRIPTION

An English Bible study (with reference to the Greek text) of the Gospel of John which the orthodox Christian tradition most commonly affirms, albeit with modern higher-critical challenges, as the work of the Apostle John. Particular attention will be given to Jesus' personal dialogues with his disciples, carefully interpreted against their historical, spiritual, social, and cultural backgrounds. These dialogues will then be examined for relevant spiritual and theological themes for Christian discipleship and ministry.

OBJECTIVES

Upon completion of this course, the student should have demonstrated in papers, classroom discussions and presentations, and examinations accomplishment of the following global domain objectives:

Knowledge

1. A preliminary understanding of what may reasonably be inferred from extant data about the historical and social backgrounds of the letter.
2. An understanding of the critical issues that bear on the question of the authorship of the letter.
3. The ability to outline from memory the basic contents and ideas of the letter.
4. A thorough grasp of the major theological and ethical issues reflected in the letter.
5. A comprehension of the particular issues and themes in the letter relevant to the practice of Christian discipleship and ministry in contemporary society.

Attitude

1. A demonstrated appreciation of the nature of the letter as sacred Scripture.
2. A willingness to lay aside previous biases and understand the letter on its own terms.
3. A desire to be personally shaped by the message of the letter.
4. A desire to explicate the universal truths of the letter in contemporary ministry and church life.

Skill

1. The ability to exegete and interpret the text of the Gospel in terms of its original purpose and intent.
2. The ability to critique modern life in terms of the ancient biblical message.
3. The ability to bring the insights of the letter to bear on contemporary ethical issues.

4. The ability to bring the theology of the letter to bear on the practice of ministry in the contemporary milieu.

METHODOLOGY

This course will utilize lectures by the professor, audio-visual presentations, dialogue between the professor and students, and seminar-type presentations and critiques by the students, time permitting.

COURSE REQUIREMENTS

1. **Time Expectations.** This course is designed to reflect AGTS standards and anticipates 50 clock hours of study for each hour of credit. In degree completion format, adult learners are expected to do most of their learning outside the classroom via the assigned activities.
2. **Bible Content Examination.** Each student must sustain an examination over the content of the Gospel of John that focuses largely on identifying subject matter by chapter. There will be a pre-test (non-graded) in the first session and a post-test (graded) in the last (using the same examination) to assist in assessing the student's learning and achievement of the class objectives. The purpose of this examination is thoroughly to familiarize the student with the text of John.
3. **Reading Report.** Each student must submit a reading report at the end of the course that logs all class reading by author, book, date, time, and so forth (including the Bible text and all readings for research assignments). A reading report form will be provided on the first day of class. AGTS guidelines normally anticipate about 1,500 pages of reading for a three-credit course.
4. **Presentation Reports (4).** Each student will prepare a written paper for sessions two (2) through five (5)—a total of four (4). The papers should be two to three (2-3) double-spaced pages in length and may be a basis for discussion or a possible oral report (depending on the class size and quality of the papers) to one or more sessions of the class beginning with Unit 2. Topics may be chosen from the unit objectives and assignments, from the list below or additional topics provided by the professor, or from special interests negotiated by the student. Each report must close with a brief (one paragraph), well-reasoned application to contemporary Christian life and ministry where such application is possible and appropriate. Topics must be agreed upon with the professor one week in advance while in attendance at a class session so that the professor may weave them into the lesson plan for each succeeding session if appropriate. **Due at the beginning of each class session (2-5).**

5. **Final Paper (1).** One of the four presentation reports must be expanded into a research paper of not less than 10 pages, employing not less than 10 sources, and presented in standard Turabian (7th ed.) form. Note: this makes five (5) total papers. **Due at beginning of last class session.**
6. **Quizzes.** The professor may choose to administer a quiz at the end of class periods 2-5 that covers information discussed in the class and assigned readings.

Possible Presentation Report Topics:

In addition to (or expanding upon) the topics that may be derived from the outline and objectives of Units 2 – 5, the student may wish to consider the following for a presentation report:

Unit 2—Significance of “*Logos* [Word];” The Baptist in John’s Gospel; Jesus’ Judean ministry; Jesus as “Lamb of God”; Jesus’ first disciples; Interpretation of Nathaniel’s “fig tree” experience; Examination of the miracle at Cana; “I am” sayings; Jesus’ seven signs; etc.

Unit 3—Exposition of: “new birth” passage; Samaritan woman passage; Jesus’ equality w. God (5:18); “Bread of life passage; living waters (7:37ff.); woman caught in adultery; Light of the world; etc.

Unit 4—Exposition of: washing the disciples; Judas’ betrayal; Jesus as Way/Truth/Life; True Vine; Nature/Work of the Paraclete; Unity of God’s People in Jn 17, etc.

Unit 5—Examination of: Jesus’ trial/s; crucifixion; resurrection; post-resurrection appearances; exposition of 20:19-23; harmony w. Synoptics; etc.

Prompt and timely completion of assignments is essential to the degree completion program. Late work will be accepted only by pre-arrangement with the professor and only on sufficient grounds. Late work submitted beyond agreed-upon dates, if accepted, may be penalized by one letter grade per week late.

*The professor reserves the right to allocate 10% of the grade for participation, raising or lowering for significant lapses or contributions.

Grades will be averaged using the following scale: F=1; D-=2; D=3; D+=4; C-=5; C=6; C+=7; B-=8; B=9; B+=10; A-=11; A=12. Letter grades are based on the official AGTS grading scale.

NOTE: A \$30.00 fee will be charged to the student’s account for every grade change even if the instructor has approved an extension for completing the work. Any exception to the policy will be made by the registrar.
